Dear Mr. Stegemann,

I write to you as the trustee of the trusts for my 3 children who are the legal owners of 92 acres on the south shore of Eagle Lake. We bought the landlocked property 14 years ago when it was advertised as "boat access only"!

Chris Hyde (President of our lake association ELPOI) recently shared news that the 100 +- Eagle Lake property owners might lose their motor boat access to the lake from the

State boat launch on Rt. 74. Clearly, this is an issue that will affect many people; Eagle Lake property owners as well as the general public that access the lake for various reasons. If the motor boat launch is closed, the general public will have to motor boat elsewhere, the majority of Eagle Lake property owners might manage because they can drive to their homes and possibly launch their motor boats from their own property, but my family (and several other landlocked property owners) will not be able to access and maintain their properties unless we can maintain partial if not full access by motor boat. It's as simple as that.

My family bought this beautiful wooded lakefront property without any of the services normal tax payers enjoy. We have no electric service. We have no plumbing. We have no road and driveway access. But, by having motor boat access we are able to maintain and enjoy our property and are willing to pay taxes for that reason. Take away our motor boat access and we essentially lose our homes (we frequently canoe to our camp, but we depend on being able to access our property by motor boat to bring in furnishings, building materials, guests, etc.)

There are plenty of other concerns I share with other Eagle Lake property owners if we were to lose our right to access by motor boat; health & safety issues, lower real estate values, etc.

But my concern as a land-locked property owner with uniquely paramount concerns of losing my ability to maintain my camp is very real and very distressing.

I want to believe that practical solutions can be found to remedy any issues (being out of compliance of APA rules?) that have prompted the APA to believe that closing (restricting use) the State boat launch on Rt. 74 is the answer.

Thank you for your time and consideration of my concerns.
