I got six of them for you, but it is an expensive proposition, something that we had not budgeted quite that amount.

That number is a variable depending upon how you count the number of places that are around the lake, there are right of ways that are associated with property. Put that right away, be a paid membership. Yes, it can be cause it's a property that is owned by somebody, but that property that right away is maybe owned by the same person.

So you count it once, you count it twice. That's the debate to be hit wrestled with, but it's approximately 85.

So if we look at the numbers that we represent, it could be 90, it could be 85, it could be 80. There are several people on the lake that own multiple pieces of property. So if you back out and say, well, they're only going to pay 1 dues even though they own 5 properties, the town is like kind of owns a piece of property. Do you count them? They're never going to come and pay their dues. The state of New York owns a piece of property or two or three.

With that, their final decision. Originally they wanted to take water from Eagle Lake. Now we're involved. They changed their mind. Their final decision is they're going to take water from the street Road. Well, pump it across to a tank on 74th at at Chilson Hill, and then distribute it down the hill into Eagle.

They are going to start work this fall. They're going to put in a alternating one lane with a couple of traffic lights on either side while they install micropiles.
